FAA officials are praising passengers onboard a space tourism flight for subduing a fellow passenger who allegedly endangered the flight. Millionaire businessman Mr Amund Black on the flight with his daughter, Ms Mia Black, said that passenger Ted Smith panicked as the flight progressed. Also onboard Professor Mike Buller, a behavioral phycologist from Columbia University, said Mr Smith rejected offers of reassurance and lashed out at passengers and crew. He reported Mr Smith making threats and demanding a change to the flight plan. Passengers restrained Mr Smith allowing a safe return to Earth where he was arrested by awaiting police.
